What's news at KGP?

It has been a while since our last community newsletter on the Katanning Gold Project (KGP). Starting a gold mine is a big responsibility, and we want to make sure that we do it right. We've been working hard on detailed technical studies to confirm our mine plan, so that we can:

- Give more information with greater certainty
- Engage with you the KGP community in a more regular and responsive way
- Better understand what interests you have and how we can best consider your views.

We will progress our work alongside our engagement activities to help plan for the changes and prosperity that KGP can help deliver with the community.

Community Reference Group

In January, we formed a Community Reference Group (CRG) after a nomination process during 2024. CRG members volunteer to work together on identifying initiatives and activities that relate to supporting biodiversity, land management, community resilience and shared prosperity.

CRG members represent a cross-section of organisations including Shire councils, Aboriginal corporations, Landcare, Great Southern Development Commission and local business associations. Three Shires Forum

Since late 2024, we've welcomed and appreciated the collective guidance from leaders of the three Shires closest to KGP, being Katanning, Kent, and Dumbleyung.

The Shires jointly provided key specific matters relating to the KGP for Ausgold's consideration. We've already indicated our strong alignment on many items that form a common agenda to be progressed over 2025:

Transport and Logistics

- Future use and impacts on Warren Road.
- Investigating transport routes from construction phases through to operations.

Local Government Operations

- Potential supply of rock to be used for resurfacing some regional roads.
- Supply of some of our non-potable water for construction uses.

Community Benefit Arrangements

- Financial contribution to a joint sustainable community benefit fund.
- Sharing some of Ausgold's available land for community cropping.


We encourage all community members to drop in for a chat. We will also hold drop-in sessions on opportunities for employment, supply of services and community engagement as the KGP develops.

About the Katanning Gold Project

The KGP is Ausgold's flagship project. We are located 275km south-east of Perth and about 40km north-east of Katanning, in the southwest of Western Australia. Katanning is the closest regional centre, and other KGP communities include Nyabing, Dumbleyung, Badgebup and Woodanilling.

Gold was first discovered in the area in 1979 and was mined briefly from December 1995 to July 1997. About 20,000 ounces of gold was produced during this time. Since acquiring the project in 2010, Ausgold has been working on 'proving up' (measuring and confirming) the gold resource at over 3 million ounces (Moz) and reserves at 1.2Moz based on extensive additional exploration studies.
